

Bachelor of Arts-Bachelor of Laws – degree planner for students commencing 2009

START HERE.....

The idea of this course plan is to give you a quick run down of how this degree works and what you need to do to complete it. Once you understand what is required you can use the blank course plan overleaf to keep track of your progress.

To complete the BA-LLB degree, you must pass a total of 40 units (including 1st year in the BA degree only), or 8 units in each year of the five year degree.

- **YEAR 1:** BA degree only: 8 first year units (level 100) comprising 6 BA units, plus 2 Law units.
- **YEAR 2:** 4 BA units, plus 4 Law units.
- **YEAR 3:** 4 BA units, plus 4 Law units.
- **YEAR 4:** 1 BA unit from the cross-listed schedule of electives, plus 7 Law units, comprising 5 core Law units, plus 1 elective from the Law Schedule of electives, plus 1 elective from the cross-listed schedule of electives.
- **YEAR 5:** Law units only comprising 4 core Law units, plus 4 electives from the of Law Schedule of electives.

IMPORTANT NOTE: Within the BA component, you must complete the requirement for one BA major, eg Political Science. A major is made up of sequential units from one discipline totalling at least 8 and a maximum of 12 (normally 2 units at level 100 (first year units) + 6-10 max of units over level 200/300 (second/third year units)).
