Discount



Commencing Semester 1, 2006 the Faculty of Business will be offering discounts to UTAS alumni and staff members. These discounts will be applicable to University of Tasmania (UTAS) alumni and staff who enrol in a Faculty of Business full-fee paying postgraduate course.

Discounts offered are 10% for UTAS alumni and 20% for UTAS staff members.

Please see the guidelines below for eligibility criteria and further information.

Alumni Discount Guidelines

1. The Faculty of Business will provide a 10% discount to UTAS alumni who enrol in a Faculty of Business full-fee paying postgraduate course. These courses are listed in Attachment A.
2. The Alumni Discount will be available for students who have successfully completed an undergraduate, masters or research degree at UTAS, and wish to take a subsequent degree.
3. Alumni who are eligible for this discount will be required to register as an Alumni Member. Alumni Membership does not incur a fee. Registration can be completed online at <http://www.alumni.utas.edu.au/membership.html>
4. The Alumni Discount offer will be part of the 'Letter of Offer' that is sent to successful applicants for their chosen course.
5. Students who become alumni by completing an articulated postgraduate course in the Faculty of Business qualify for the Alumni Discount if continuing directly on to a Faculty of Business Specialisation, as referred to in Attachment A.
6. This discount will not be retroactive and will be applied as of Semester 1, 2006, when the guidelines come into effect.
7. For alumni who are currently enrolled in a full-fee paying postgraduate course through the Faculty of Business, this discount will be applied automatically from Semester 1, 2006. Alumni in this category are still required to register as an Alumni Member. Alumni Membership does not incur a fee. 8. Alumni who are also UTAS staff may prefer to use the staff discount.
9. The Faculty of Business's discount is available to domestic students only. International Services offers international students who are UTAS alumni a comparable 10% discount. Please contact International Services for information: International.Office@utas.edu.au or +61 3 6226 1803.



Staff Discount Guidelines

1. The Faculty of Business will provide a 20% discount to UTAS staff¹ who enrol in a full-fee paying postgraduate course. These courses are listed in Attachment A.
2. The Staff Discount will be available to all full-time and part-time continuing staff and staff employed by UTAS, on fixed-term contracts of 12 months or more. For staff on fixed-term contracts the term of their employment contract must extend beyond the end of the semester in which the units of study are undertaken.
3. Staff will be subject to the standard rules applying to the Services and Amenities (S&A) fees. S&A fees will be waived for a single 12.5% unit per six month period. Staff will need to meet the costs if undertaking more than one unit per six month period.
4. The maximum discount available is 20%. For example, if a student applying for a discount is both a staff member and a UTAS alumnus, the discount will be capped at 20%.
5. Financial and Business Services confirm that Fringe Benefits Tax (FBT) is not payable. Contact Business Services (03) 6324 3655 should further information be required.
6. Staff should note UTAS offers the Staff Development Initiative for units that are Commonwealth Supported. Information on that initiative can be found at http://www.utas.edu.au/staffdev/docs/guidelines_sd_initiative_06.doc
