<b>Unit Description:</b>	Students undertake substantial research on an approved subject leading to a major journalistic project or thesis. SPECIAL NOTE: Taken over two sequential semesters on a part-time basis
<b>Unit Aims and Objectives:</b>	This unit will give students the opportunity to pursue a specific topic of interest while deepening their understanding of aspects of journalism.
<b>Learning Outcomes:</b>	At the end of this unit students will have developed skills in: <ul style="list-style-type: none"><li>• Journalism research</li><li>• High-level scholarly and journalistic writing/production</li></ul>
<b>Required Texts:</b>	Individual reading lists to be provided by supervisor.
<b>When Taught:</b>	Students will work independently with consultation with supervisors.
<b>Assessment:</b>	Work on the 12,500-word (or equiv) major journalistic project, which will be completed in HEJ704 Major Research Project Part-time B.

## ASSESSMENT

There are two kinds of projects to choose from:

1. A piece/pieces of **researched print journalism**. This should be a long feature-style piece of journalism or a closely related series of features, based upon strong journalistic principles and capable of being published in an acknowledged forum. The student should make a statement about the forum within which the piece could be published (whether or not it is actually published eventually). This work should be about 7,500 words long. It **must** be accompanied by a 5000-word exegesis (total word length for journalistic product and exegesis should be 12,500 words) that shows scholarship around the topic of your work. You must read the literature pertinent to your topic and show how your piece of journalism fits within the context you have chosen. Your exegesis must be scholarly and make use of the Harvard referencing system.
2. A **radio documentary** intended for an acknowledged forum (e.g. ABC's Background Briefing, Street Stories, or The Night Air). The length of the documentary will be dictated by the forum nominated. Regular rostered access to recording and editing facilities will be provided to undertake production work. This project **must** also be accompanied by a 5000-word exegesis that shows scholarship around the topic of your work. You must read the literature pertinent to your topic and show how your documentary fits within the context you have chosen. Your exegesis must be scholarly and make use of the Harvard referencing system.

**The project is worth 100% of your unit mark and is due in Semester Two at 4pm on Friday 9<sup>th</sup> October.**

### Project assessment criteria

All projects will assess all of the Learning Outcomes for this Unit and will be marked according to the following criteria:

1. Evidence of efficient planning and management of a research project, incorporating original work, within clearly defined constraints of time, resources and (in the case of journalism projects) prospective identified publication/broadcast forum and audience.
2. Clearly outlined methods of collection of information, using suitable techniques (e.g. questionnaires, journalistic interviews, etc.).
3. Sound analysis and interpretation of data and information, within a clearly specified and defined analytic framework, together with a discussion of methodological considerations. Those undertaking the exegesis should include the requirements of this criterion in that part of their work.
4. Effective presentation of data and information using suitable written, numerical, recorded and/or illustrative techniques.

5. Well-developed and engaging discussion of the results and conclusions that arise from the investigation OR well-developed and engaging journalistic writing that draws upon research and scholarship to produce a substantial and readable feature or series of features that would be suitable for publication in an acknowledged forum OR professional broadcast quality radio storytelling.
6. High-quality presentation of the document in effective and grammatically correct English. The style guide provided must be adhered to in any journalistic piece. All scholarly work (i.e. the entire media research project or the exegesis accompanying journalistic work) must feature the Harvard referencing system and a full bibliography.

## **The exegesis**

An exegesis is a scholarly essay that reveals the underlying concepts informing the primary work, in this case the piece of journalism. Here is one explanation of this kind of work that you might find useful:

[The exegesis] discusses origins, possible options, explains why certain paths were followed rather than others. It might set the work in a contemporary context, comparing it to that of other writers. The exegesis might explain the creative product's weaknesses, referring to the student's developmental stage. At the conceptual end the exegesis might offer a coherent theoretical appraisal, proving how the student has incorporated theory into practice. (Kroll, Jeri (1999) "Uneasy Bedfellows: Assessing the Creative Thesis and its Exegesis" TEXT Vol 3 No 2)

An exegesis should show evidence of broad reading - both analytical works around journalism studies and works specific to the topic being elucidated in the larger piece of writing. You should consult with your supervisor about the content of your own exegesis.

## **General information**

### **Staying in contact**

Following acceptance of your project abstract, students will be assigned a supervisor or supervisors for the duration of the project. It is very important to keep in contact with supervisor/s. Students will be required to attend some seminars during semester, and to have fortnightly contact throughout. Students should allow about one hour per fortnight, at an agreed time, to either meet face-to-face or have a telephone conversation with your supervisor. Regular e-mail contact is also encouraged.

### **Supervision**

The major project is an independent research essay or research-based journalism and students are solely responsible for researching and writing/recording/editing the piece. Supervisors will provide advice and feedback but it the student's responsibility to fulfil the assignment requirements and to polish and proofread the work before submission. As this work is being undertaken at Masters level in a writing discipline, a very high standard of grammatical and journalistic correctness will be expected in all the written work. Students will need to be familiar with the requirements of the journalism style guide and should consult the suggested editing texts listed in the style guide to ensure that the work is of the highest standard.

**Project submission**

Students must submit three copies of the project and each copy should be bound. The work should be referenced according to the discipline's standard format, the Harvard referencing style. Information on the correct use of this form of referencing will be presented early in semester. The work should be typewritten and double-spaced. The project must be submitted in hard copy form, accompanied by a signed cover sheet acknowledging that the student has read and understood the University's plagiarism policy (reproduced at the end of this document). Under University policy, evidence of plagiarism will result in failure.

**Marking**

The project will be assessed by three markers: the supervisor, another staff member from the School and an external marker. The external marker reads and marks all the projects. Comments from all the markers will be made available to students after results are released.

**Important note:** For those students enrolled in HEJ701 for Semester 2 2009, the project is due by 4pm on Friday 9<sup>th</sup> October. This is regarded as an exam date, so any request for an extension will require the same level of documentation as an application for a deferred exam. It is crucial that you submit your project on this date, and you should pace your work throughout semester to ensure you can meet this deadline.

### IMPORTANT INFORMATION

#### Submission of assignments

Students are required to submit a signed assignment cover sheet with every assignment. The cover sheet includes a declaration that all material submitted is your own work except where there is clear acknowledgement or reference to the work of others. Assignment cover sheets are available from the School office or the School website. **Assignments submitted without a completed, signed cover sheet will not be marked.** Students who submit assignments without a signed cover sheet will be contacted once via their UTAS email address; in such instances the cover sheet should be completed within two weeks of the assignment due date. Assignments must be submitted in hard copy (not by email) via the assignment slot at the School office. If there are additional submission requirements (eg the use of Turnitin) this will be specified in your unit outline. Students are required to keep copies of all submitted assignments.

#### Late assignments

##### Undergraduate units (100, 200 and 300 level)

Late submissions will be penalised as follows: 5% of the available marks for the first day, and then 2% per working day thereafter.

##### Honours and postgraduate coursework units (400, 500 and 600 level)

Late submissions will be penalised as follows: 10% of the available marks per day for the first five (5) working days and 50% on the following day.

##### Honours and postgraduate research project units (400 and 700 level)

Honours and postgraduate research project submission due dates are treated as the equivalent of exam dates and therefore, late submissions will not be accepted.

**Late work will be accepted without penalty if accompanied by a medical certificate for the relevant period or equivalent documentation in the case of a serious non-medical reason but you must contact the unit coordinator prior to the assignment due date.**

#### Return of marked assignments

Assignments submitted on time will be returned within three weeks of the due date; once on time assignments have been returned no further late assignments will be accepted. All marked assignments will be returned in tutorials unless otherwise advised. In some cases, particularly where an assignment is the final, exam equivalent piece of assessment, the marked assignment may not be returned until after final unit results have been released.
