**\*Steps taken by Council for dealing with conflict and members actions to address conflicts:**

1. Any member of Council who has a potential conflict of interest in a matter being considered or about to be considered by Council or by a Council committee must, as soon as possible after the relevant facts come to the member's knowledge, disclose the nature of the potential conflict of interest to the Chancellor or Council committee Chair and to the University Secretary. The member must also disclose the nature of the potential conflict of interest at the next scheduled meeting of Council.
2. The University Secretary is to indicate in the agenda papers if there are any items in which it appears likely that any member of Council may have a potential conflict of interest.
3. The University Secretary is to record any disclosure of interest by a member in the minutes of the meeting of the Council and must maintain a register of interests for members of Council.
4. Unless Council determines otherwise in a particular case, a member who has declared an interest must not:
  - be present during any deliberation of Council in relation to that matter; and
  - take part in any decision of Council in relation to that matter.
