

# Academic Senate Meeting – 3 March 2023 Report to 27 April 2023 University Council Meeting

The following major items were considered by Academic Senate at its 3 March 2023:

#### **Outcomes of Academic Senate Annual Review**

The Chair updated members on the outcomes of the internal review of Academic Senate that occurred in 2022, noting that the gathering of input from Senate members and members of the wider University community was key to implementing positive changes going forward. The establishment of the Monitoring and Assurance Committee (MAC) to provide oversight, on behalf of Academic Senate and its committees, of elements of the Higher Education Standards Framework that relate to institutional monitoring, and the upholding of higher education standards in relation to policies and procedures, was highlighted as being one of those positive changes. Senate were informed that MAC will meet for the first time on 27 March and are scheduled to meet six times in 2023.

The collegiality of Senate was highlighted throughout the internal review and the Chair noted that the numerous networking and conversational aspects of Senate that members enjoy will continue throughout 2023. Additionally, the Chair advised members that an external review of Senate is planned for 2024.

#### ChatGPT and Artificial Intelligence (AI)

Academic Senate engaged in an in-depth discussion on the challenges and opportunities presented by the recent release of ChatGPT and other generative AI software, noting the speed at which subsequent releases of updated software will continue to occur. Senate were informed that the challenges this software presented in relation to breaches of academic integrity were not new to higher education, but the opportunities for generative AI to assist in learning and teaching, and research were an exciting development for the sector. Senate endorsed the University statement on the use of ChatGPT and generative AI technology, and provided significant input into the wording of the new academic integrity breach type related to this technology.

### Shanghai Ocean University (SHOU) – 2022 Course Quality Assurance Report

Whilst speaking to the 2022 Course Quality Assurance Report from SHOU, the Director, Academic Quality and Standards noted that 2023 marks the twenty year anniversary of the partnership between UTAS and SHOU. The Executive Dean, CoBE informed Senate that nearly 6000 students have graduated from the program in that time. In relation to the report, the student experience was noted as being key to ongoing quality assurance with the review of student satisfaction results currently being worked through with the Joint Management Committee that manages the partnership.

## **Update to HDR Candidature Support**

The acting Dean of Graduate Research and the Deputy Chair, Academic Senate updated Senate on work being done to ensure quality support and infrastructure for Higher Degree Research (HDR) candidates. Senate were informed that this work had progressed to implementing better infrastructure solutions for HDR students and strengthening existing support mechanisms, and that discussions were continuing to address any barriers to student success which may be posed by the geographical location of supervisors and support infrastructure.

### **Annual Reports from Senate Committees**

Academic Senate received and noted the 2022 Annual Reports from the University Admissions Committee, the University Learning and Teaching Committee, the University Research Committee, the University Course and Unit Proposals Committee and the Student Experience Committee.



# **Next Meeting of Academic Senate**

The next scheduled meeting of Academic Senate will be held on Friday 12 May 2023. A special meeting of Academic Senate will be held on 3 May 2023 to consider the University's response to the forthcoming referendum.

The course has not been available at all in 2021 or 2022. With the introduction of the MBA suite (approved by ASCAC on 24 March 2022) there is now another Graduate Certificate in Business Administration that will be used for exit purposes, making C5Z surplus to requirements.</li> </ul>

The College of Health and Medicine proposed to amend the Minimum Time to Complete for H3N to 2.4 years, and retain the Maximum Time to Complete at 7 years, commencing in 2024.</li> </ul>
СоНМ	Significant Amendment - M1D Diploma of Dementia Care	<ul> <li>Academic Senate approved proposed amendments to course M1D Diploma of Dementia Care. This course was first opened to enrolments in 2019, and students enrolling at that time are now reaching the end of their course duration. Due to majority of students studying part-time a significant number of requests for extension are now being received for this course. As such the college proposed to extend the Maximum Time to Complete from 3 years to 4 years.</li> </ul>

CoSE	Significant Amendment - 70H Undergraduate Certificate in Antarctic and Climate Science	<ul> <li>Academic Senate approved proposed amendments to course 70H Undergraduate Certificate in Antarctic and Climate Science. Changes to the Minimum and Maximum Times to Complete were proposed to align this course with other Undergraduate Certificates, i.e. a Minimum Time to Complete of 0.5 years and a Maximum Time to Complete of 2 years. Some consequential changes to the Course Specification were also proposed.</li> </ul>
CoSE	Component Discontinuations - P3O Bachelor of Science and S4E Bachelor of Science with Honours	<ul> <li>Academic Senate approved proposed amendments to courses P3O Bachelor of Science and S4E Bachelor of Science with Honours, and consequential changes to the following components: ITSMJR03, KCSMJR05, PSYMJR04, PWDHSP01, CSCHSP01, DSCHSP01 and MARHSP02 and NPSOTH33. Following recommendations from a recent review of the Bachelor of Science, the College of Sciences and Engineering proposed to remove several majors in P3O Bachelor of Science and the associated specialisations in S4E Bachelor of Science with Honours.</li> </ul>
